Student Minister Guide – SHOCCO SPRINGS

STUDENT MINISTER PREP

- Select a location to meet with your FGL's. This can be after service, on campus that evening, or in a home. **However, they must be on July 12th**
 - Notify Kendall Gast by sending her a calendar invite of your meeting details by **June 15th**
- **Send invite to your campus FGL's by June 11th**
- **FGL must complete the video trainings by July 20th**

- Please note, the goal is to spend more time casting vision and praying than you do on the details of the packet!

MEETING OVERVIEW

CAST VISION FOR CAMP (15 mins)

- Welcome everyone. Open by praying for your campus FGL's.
 - **Discussion Question: Does anyone have a story of how camp impacted their walk with Jesus?**
- Cast vision for why we do camp: Turn down the volume of the world and turn up the voice of God.
- Share a personal story of how you have seen God use camp.

- What do you think will be most impactful to students in this curriculum?

Encourage them to watch the videos of the curriculum. This is a requirement prior to Student Camp.

- Tell them to look over the passages of scripture & curriculum leading up to camp.
- Explain to them the differences from Midweek. At camp they are facilitating conversation and teaching scriptures.

SHEPHERDING STUDENTS (15 mins)

- **Please emphasize the importance of Mandatory Reporting** — Being a Mandatory Reporter means that if a minor (under 18 years old) student reports physical, emotional, sexual, or verbal abuse of any kind, we need to report it. All of us. Every pastor, minister, intern, serve staff, counselor, nurse, etc.
- Remind FGL's that they are mandatory reporters. They need to review the mandatory reporting training in the video training, and they can go to their student minister if they have questions while at camp.
 - **Examples of other things to report to Student Minister:**
 - Imminent risk of self-harm
 - Imminent risk of being harmed by others
 - Imminent risk of harm to others

PRAY TOGETHER (25 mins)

- Pray students would surrender their lives to Jesus and that the Gospel would change everything about everything in their lives.
- God is first. Pray students would surrender to that reality. Ask God to reveal anything competing for their worship and that students would respond by giving him their first and best.
- Pray students would return home bold in their faith and ready to impact their homes, schools, teams, and neighborhoods by reaching one more.
